appeal on more than 250 state and federal cases, including many cases that have transformed criminal practice in Washington. Her first Washington State Supreme Court case, State v. Leach, decided in 1989, reformed misdemeanor charging practices statewide. She has represented defendants in eight capital cases in Washington, Alaska, and Colorado, winning reversal of the death sentence in several. She also considers her work with Doris Green, a defendant in the Wenatchee Witch Hunt, which resulted in Ms. Green's release from DOC and allowed her to reunite with her children, to be a career highlight. While Suzanne concentrates on appellate work, she has appeared in courts at every level of the criminal justice

system, from Washington's municipal and district courts all the way to the United States Supreme Court.

Even in cases where she did not prevail, she fought the good fight. Says colleague Anna Tolin, "Suzanne's oral argument in front of the U.S. Supreme Court in the Cal Brown death penalty case was an impressive example of her talent and tenacity."

Suzanne has also been the co-chair of WACDL's amicus committee since 1999, a role in which she has greatly expanded the influence WACDL in the appellate courts and has worked to ensure that WACDL's voice is heard on every significant criminal law issue raised before the Washington State Supreme Court.

Seattle attorney **Lila Silverstein** is an appellate public defender who appears in all three divisions of the Washington Court of Appeals and the United States Court of Appeals for the Ninth Circuit, and has argued over 20 cases before the Washington State Supreme Court.
